

## 1. Call to order

Having established that the WES General Assembly was called in accordance with the WES bylaws, WES President, Linda Giudice, called to order on 17 May 20217 at 18.30 PDST in Ballroom B at the Vancouver Convention Centre West, Vancouver, Canada.

### 2. Approval of the 2014 general assembly minutes

Linda Giudice requested the membership to approve the minutes from the 2014 general assembly.

Upon motion made by WES member, Daniel Martin, seconded by WES member, Luk Rombauts, it was unanimously resolved that the minutes of the General Assembly held on 30 April 2014 be approved as presented.

### 3. Report of the president

Linda Giudice thanked members for the privilege of serving as president of WES for the past three years and provided a summary of the society's achievements in this time, including:

- The 2014 World Congress on Endometriosis (WCE2014) in Sao Paolo, which attracted 1238 attendees from 68 countries around the world.
- At WCE2014 the society awarded its third Rodolph Maheaux Award, first David Healey Award, and the SBE award for the best video presentation.
- WCE2017 will be recognising the best poster presentation for the first time in addition to the aforementioned awards.
- The society has sponsored a research priorities meeting during each congress since 2008. The result of the 2014 meeting was a list of recommendations from the Global Consortium on Endometriosis Research Priorities, published in 2016. The next research priorities meeting will occur this Sunday, 21 May 2017, with the same goals.
- WES has sponsored several consensus meetings on endometriosis including the meeting held in Montpellier on current management of endometriosis, in Sao Paolo on diagnosis and classification, and just yesterday on patient centred outcomes.
- A strategic planning meeting was held in connection with the SRI meeting in San Francisco in March 2015 attended by Linda Giudice, Ludwig Kiesel, Robert Taylor, Sun-Wei Guo, Hilary Critchley, and Lone Hummelshoj and from which the following priorities were outlined for the next few years:
  - Improve communication and information dissemination
  - Establish authority and leadership
  - Increase stakeholder participation
  - Increase partnerships with stakeholders and funders
  - Add value to and expand membership
- The society initiated a search for a secretariat as part of freeing up Lone to concentrate on projects, rather than the day-to-day running of WES. International Conference Services (ICS) were appointed in 2015 to support with administration, membership management, and financial management. ICS was instrumental in revising the society's bylaws.
- Volunteer participation has increased through the appointment of 40 WES ambassadors, who have been serving on committees and were instrumental in furthering our interests and goals.

- WES formerly had an e-Journal which has now been replaced by conference reports, reviewed by Luk Rombauts, by young investigators. To date reports have been completed from SRI, ESHRE, SSR, 16<sup>th</sup> World Congress on Pain, ASRM, and the 3<sup>rd</sup> European Congress on Endometriosis all published on the society's website.
- WES has been building alliances through collaborations with FIGO who is now able to represent WES and endometriosis at WHO and UN levels.

## 4. Approval of the 2016 year-end financials

WES Treasurer, Ludwig Kiesel, presented the financial report with special thanks to Lone Hummelshoj and ICS staff for their assistance with preparing the numbers.

An overview of the society's revenue and expenditures from 2014-2016 was presented including:
